Matters arising:

- AECOM Report – Nick DeWitt raised a question as to the 77 odour related issues that only 12 were identified as landfill

Rob Bailey presented an Operational update.

Complaints: The combined WMNZ/AC Register of Complaints was presented.

Odour: explained no more than 2 gas wells off at a time. Unusually wet weather contributing to odour.

A noise bund has been built in the western corner. Bob Gibbs expresses concern around noise with the generators that are now planned for Q4 2018. Marshall Day commissioned to carry out noise assessment.. Report to be shared once available.

Rob L can hear the generators over the last couple months, particularly with northerly winds. Suggested a comparison be made from Marshall Day report at same time for the previous year.

- Concerns raised by KS regarding x2 large rubbish piles by DF Pony Club on the Northern Landfill. WMNZ to clear. Also dust goes straight into his home. RB to investigate which road in particular to see what additional steps can be taken to minimise dust.
- Louise Johnston to investigate why calls are not returned via the Pollution Hotline
- Nigel Donovan to provide a list of people available for complaints & to distribute council findings to Rob L regarding the AECOM report
- Steph Dryland to provide Rob L with reports completed under Condition 27D
- AC, ND and others on site Thurs 15 March for the Compliance Inspection. Redvale have not taken in any more tyres since Dec 2017 & will not be taking anymore. The stockpiled tyres will be transported to the new tyre recycling facility at Wiri for processing into AFR (alternate fuel) in the production of cement.
- Louise Johnston raised the issue of the public consultation ongoing to 28 March 2018 “Have your say on Auckland’s future” with respect to Rodney Board plans, which include Green Rd Master Plan. AC Rodney Board are seeking support for the development of the area for active recreational sports/activities
