Matters arising:

- Chairman – a call for a new Chairman was sent out. S Dryland received one nomination via N dW for Warwick Hojem. Warwick is known to both Nick and Louise Johnston. Warwick's CV was distributed to the committee for their review. Warwick to be invited to both the Christmas Dinner to meet the committee members and the next CLC meeting.
- Marshall Day report – distributed via email and will be forwarded to Council also.
- The tracking of material onto Dairy Flat Highway – Nick expresses concern around dirt etc being tracked onto the highway, making road markings very hard to see at night and could be dangerous to those who aren't familiar with the roads. Kirk agreed. WMNZ agree it is unacceptable to have dirty roads. There was an issue last week causing the 1<sup>st</sup> wheel wash to be out of action. Rob Bailey explained how the wheel washes work and where the water comes from. An air blaster was suggested as another potential solution. There has been some instances where trucks have been going too fast through the wheel wash units and cattle grids. Drivers have been pulled up and reminded of the correct procedure.  
Redvale have the equipment means to keep the public road clean but are not approved to operate on the highway. There are formal requirements required by AT. L Johnston will raise the issue (***Response attached***) and WMNZ will investigate further.
- Leachate irrigation on the landfill cap – discussion around the potential effects from leachate irrigation. Irrigation is only a consideration at this stage. If it was to progress, there are steps WMNZ would need to work through before that could be implemented.
- Odour monitoring hotspots – unfortunately due to no Chairman this could not be fully completed, as the Chairman was to collate the information and forward it to Shayne from AC. NdW informed he has called Council with odour complaints, which were responded to, but no feedback was provided to him as he requested.
- Online access for complaints – it was discussed that the website should be open to the public for complaints. It was confirmed during the meeting that complaints can be lodged through the website. It was suggested that the Redvale community site should be more

easily found through the main WMNZ website (*see attached document showing steps to find Redvale and relevant websites*).

L Johnston has met with head of Pollution Hotline and the information shared is not streamlined. Chris W also advises Council that we need addresses noted to be able to investigate odour complaints thoroughly.

- NdW tabled photographs of two sucker trucks unloading materials at tip face. These are approved loads from within site i.e. LEU residual material.

Rob Bailey presented an Operational update. Currently using cell 19b. Managed Fill coming in is being used as cover. Construction season to start next month. Generators 13 & 14 are underway, walls are now up with absorbent material to follow. New blower being installed. Same area as the current set of blowers so there will be 3 going forward. Stockpiling of clean clay for the final batter is ongoing.

Complaints: The combined WMNZ/AC Register of Complaints was presented.

Wind Speed data etc to be checked for next report.

Review current wheel wash system and practices and look at opportunities for irregular clean of road when required.

Regulatory Issues:

- Nigel has completed a regulatory visit. Ammonia found in pond 1 – A/C unhappy with WMNZ response. A warning letter was issued. Unusual to see ammonia levels up although TL2 is low. 0.9 is standard, Redvale was registered at 2.

General Business:

- Community informed the stockpile of tyres has now gone. However, we are holding shredded tyres onsite for a limited time in containers. Destined for Clients.
- B Gibbs appreciates percentage of airspace filled but now wishes to have cubic volume figures.
- L Johnston advises new speed restrictions to be put in place at a few spots along DF Highway and a round a bout at the intersection of Coatesville/Riverhead Highway. Also remember to have your say on the future park in Green Road, Dairy Flat. Council want to hear what spaces and activities the Community want to see in the new park and sport grounds. The survey is quick to complete and closes on the 21<sup>st</sup> of September.
